Speaker's Career Highlights

Peter Munk is the Founder and Chairman of the Board of Barrick Gold Corporation. A well-known Canadian business leader and philanthropist, Mr. Munk has built several enterprises with international scope that have achieved outstanding performances.

From a standing start in 1983, Mr. Munk and his management team have developed Barrick into the pre-eminent gold mining company. In early 2006 Barrick completed the successful acquisition of Placer Dome Inc. and created a platform for further value creation for its shareholders. Barrick now has high-quality operating mines and development projects in the U.S, Canada, Australia, Peru, Chile, Argentina, Tanzania, Papua New Guinea and the Dominican Republic.

Barrick has established a track record of rapid development since its formation and has set standards of excellence. It ranks as the only gold producer in the world with an A credit rating and has more than 20,000 employees working on five continents.

Until its sale to Brookfield Properties for \$5.4bn in 2006, Mr. Munk was also Chairman of the Board and controlling shareholder of Trizec Properties Inc., a Real Estate Investment Trust (REIT) which was one of the largest owners and operators of commercial office properties in the U.S., as well as Chairman and CEO of Trizec Canada Inc., a Canadian corporation primarily engaged in the U.S. real estate business through its interest in Trizec Properties.

He has lived in Toronto for most of his life, having graduated from Electrical Engineering from the University of Toronto in 1952.
